SUDDEN DEATH OF ANDREW C. COUSE

General Manager of the Slingerlands Printing Company—Prominent in Religious, Fraternal and Political Activities—Kind-hearted and Patriotic.

A great shock and a terrible gloom was cast over our village Sunday morning when the news was flashed through the community that Andrew C. Couse, one of our most active and prominent citizens, had died at 8:45 o'clock while sitting at his desk looking over some papers, apparently in the best of health. Dr. D. C. Case, who was immediately summoned, pronounced death due to arterio sclerosis.

Mr. Couse, who was 53 years of age, a stockholder and the general manager of the Slingerlands Printing Company. When but two years ago he started to work for Cornelius H. Slingerland in the printing office and through his integrity, skill and executive ability he rapidly climbed to the top rung of the ladder and was acting as superintendent of the establishment when Mr. Slingerland died over three years ago. Shortly after Mr. Slingerland's death, a stock company was formed and Mr. Couse was made general manager.

The deceased was a son of the late Squire David Couse and Jane E. Cousing. On July 25, 1868, Mr. Couse was married to Miss Anna V. Saunders, daughter of the late Mr. and Mrs. James Saunders of Athens. Besides his wife, he is survived by an adopted daughter, Jennie E. Couse, wife of Dr. William Lounsbury of Elmsted, N. J., and three brothers and a sister, Frank, David and Robert Couse, all of this village, and Mrs. George Mowbray of Lake Pleasant.

Mr. Couse was a staunch Republican and always took a prominent part in local politics, although he never possessed any desire to hold office. He served on the Republican executive committee of the first district of the town of Bethlehem for the past twenty years or more. After the death of his father, he was appointed to fill the balance of his term as justice of the peace for this district and he performed these duties admirably. For several years in succession he was elected a member of the Slingerlands board of education. He has been an officer in the Slingerlands Methodist Episcopal church over thirty years and for several years acted in the capacity of superintendent of the Sunday school. Mr. Couse was a thirty-second degree Scottish Rite Mason, a member of Friendly Union Lodge, I. O. O. F., of this village, the Royal Arcanum of Albany, the Masters' Lodge No. 5 of Albany, and the Fort Orange club of Albany. He was not only always keenly in sympathy with all civic interests pertaining to our community, but he gave liberally of his time and money. He was patriotic and active in all war campaigns, and was chairman of the men's committee for the fourth Liberty Loan in this district. He was also a member of the executive board of the Slingerlands Red Cross branch. No person in this village was better known by man, woman or child, or more highly respected than our loyal friend and neighbor, Andrew C. Couse. He was kind, considerate and charitable, possessing a pleasing personality, and he will be greatly missed in our community.

The Rev. H. M. Boyce of the M. E. church, assisted by the Rev. C. M. Sturgess of Albany, formerly of Slingerlands, officiated at the funeral, which was held from the house Tuesday afternoon and was largely attended. The casket was banked with many beautiful floral pieces. Burial was in the Albany Rural cemetery. Employees of the printing office acted as bearers.

RED CROSS NOTES

For nearly a year the news concerning the plans, work and personnel of the Slingerlands Red Cross branch has been in the hands of the secretary, Mrs. L. G. McCoschic, who has performed that duty, as has every other entrusted to her, with the utmost faithfulness. In her death which occurred a week ago, the organization lost a sympathetic, conscientious and untiring officer, the community a helpful friend and neighbor. It is with a feeling of irreparable loss and deprivation that her Red Cross associates face the work of the future, realizing as they do the many superior qualities which she brought into action and her value as a co-worker. In all that Mrs. McCoschic did for her country through the Red Cross or in any other way, she maintained the highest standard of thought and has left an influence which will go far toward carrying on the work still to be done, having proved herself as devoted to the ideals for which our nation stands as any soldier on the field of battle. The members of the Slingerlands branch of the American Red Cross can honor her memory in no way that would be more acceptable to her than by resolving and seeing to it that the great work in which they have undertaken to assist becomes more sacred because of her devotion, that nothing is left undone which can in any way further the end which all have in view—the end of the war and the return of our boys.

It is seldom that an executive committee of any organization is called upon to give up two prominent members in the short space of one week, but that has happened to the Slingerlands branch. Andrew C. Couse, whose death came most unexpectedly on Sunday last, was a valued and staunch supporter of all Red Cross activity, an advisory member of the committee and one upon whom all dependence could be put whenever help was necessary. His place can never be entirely filled, the memory of his goodness can never be lost, his example must ever fill the minds of those who are left to carry forward the plans and hopes in which he was so much interested. Again it may be urged, the truest way to show appreciation and regard for the loved ones that are gone is to keep in view their ideals and try to do as they would have done.

There is much work piled up ready for helping hands. Hospital garments by the hundred are being asked for by our doctors and nurses on this side of the ocean as well as in foreign lands. At the sewing room in the school house machines, material, patterns, are awaiting the workers. An earnest appeal is hereby made that every one who can do even an hour's sewing at a time will come and help in this most necessary work. There is absolutely no limit to the need and certainly in this village where so many homes have felt the absence caused by the war there should be no lack of interest or activity in any line that can by any possibility help the Red Cross in doing for us the work which we are unable to do for the boys by ourselves.

If for any reason it seems better or easier to take the work home it is entirely permissible to do so, but for the sake of those we have sent from the village let us use every bit of time possible in helping them to win the war. There have been 44 pairs of socks, seven helmets, two sweaters and a pair of wristlets taken to Albany headquarters this week, and it is urged that every one who can knit socks and sweaters apply to the chairman of the Slingerlands branch for yarn. Remember the need will be greater as the cold grows more severe. Every pair of socks will mean warmth, perhaps life itself to some of our dear lads.

EARLE HEVENOR WAS WOUNDED IN FRANCE
Recovering in Base Hospital—Praises Red Cross for Wonderful Work—Will Receive Two Gold Stripes in November for Wounds and Service.

Private Everett Earle Hevenor of Company E, 39th Infantry, American Expeditionary Forces, was wounded by a machine gun bullet on the morning of Sept. 29 on his third trip over the top. Writing from Base Hospital No. 7, situated near Tours in southern France, he says in part: "I have had several narrow escapes when on the line. The second time I was up, my rifle was badly wrecked by a bullet from a sniper. I also had a large piece of shrapnel hit my helmet, but it did not go through. This time I was standing beside my company commander, when he was shot in the left arm. While I was bandaging up the wound a second bullet hit him in the left shoulder. The bullet which struck me in the chest on the right side traveled across to the left side and stopped under my left arm. Two of my comrades helped me to the first aid station. From there I was taken to a field hospital. I spent the night there and we were shelled by the Boche. They killed ten of the fellows connected with the hospital. A piece of shrapnel came through the roof of our tent and splattered dirt all over us. There were about fifty fellows in the tent and we never expected to get out alive. The next day we were taken in ambulances to an evacuation hospital, where my bullet was taken out. After being there four days we were put on a Red Cross train and brought to this hospital. Every one connected with the hospital and the Red Cross are very kind, do all they can to make us happy, forget the

My wound is healing fine and it won't be many days before I will go back to my outfit and ready to go after the Hun again." Private Hevenor is the son of Mr. and Mrs. Everett L. Hevenor of this village, and they assume from war department reports that he was participating in the American drive which wiped out the St. Mihiel salient when he received the wound. He is a runner and the duties of a runner are hard, dangerous and one of the most important on the battlefield. He will receive two gold stripes in November, one for being wounded and the other for six months of foreign service.
